


Figure 3. Will the value of children's attitudes increase if parents and teachers work togethe Based on the respondents from the diagram above, it can be seen how the options or opinions given by teachers and students, Results and discussion Instilling character education through habituation in schools with the help of parents, teachers are asked to be good role models for students in an effort to strengthen the cultivation of character education in schools. The role of parents also determines the success of penan Teachers must familiarize characters such as religious, honesty, tolerance, discipline, social care, creative, independent, environmental care, Respondents chose with different answers, some chose to agree, strongly agree and disagree. Researchers conducted research in schools at the aliyah level which can be seen in the diagram above, the acquisition of data that can be seen from teachers and students is 68% of teachers And students voted in favor, 30% of teachers and students who voted strongly agreed, 2% of teachers and students who voted disagreed. From the results obtained, it can be seen in the diagram above that more teachers and students voted in agreement, compared to disagree. Because when viewed from the benefits of applying character to students is very important.




Figure 4. Influence the closeness of parents and teachers in shaping student morals
