Based on the Central Statistics Agency (BPS) report, the number of unemployed in Indonesia in August 2021 was 5.86%, down by 0.63 percentage point compared to August 2021. The statement regarding the increase in unemployment was also explained in a study which stated that during 2021 to 2025 there would be an increase in the unemployment rate of 0.05%.

# Unemployment According to Islam

Unemployment is a macroeconomic problem that affects humans directly and is the most serious problem. For most people, losing a job means reduced living standards and psychological stress. Unemployment is not related to those who do not work, but do not or have not found work. So unemployment is a group of people who want to work, are trying to get a job but have not been successful in getting a job. Sadono Sukirno provides an understanding or states that unemployment is a condition of a person (individual) whose age is included in the labor force, wants to get a job, but in reality the individual has not found a job or to fulfill his life needs. Unemployment is a strategic problem in the macro economy, because it has a direct effect on the standard of living and the psychological pressures of society. Unemployment is defined as a condition indicating a resource that is not used.

According to one scholar, Dr. Yusuf Qardhawi revealed that unemployment is divided into two types, namely: 1) Jabariyyah (forced) unemployment, namely unemployment where a person does not have the slightest right to choose this status and is forced to accept it. Unemployment like this generally occurs, because someone does not have the slightest skills. 2) Khiyariyyah unemployment, namely someone who chooses to be unemployed, even though he is basically a person who is able to work.

Unemployment in this case explains that there are reasons that make a person unemployed so if based on the cause of unemployment there is frictional unemployment, cyclical unemployment, structural unemployment, seasonal unemployment, technological unemployment, political unemployment, and deflated unemployment. Meanwhile, when viewed from its characteristics, unemployment is divided into open unemployment, hidden/ disguessed unemployment, seasonal unemployment, and half unemployed.




Figure 1. Factors Causing Unemployment
